Agreement for Application for Scholarship by the Master's Students Studying (or Directly Studying) at the Ph.D. Program

The Department of Photonics of National Sun	Yat-sen University (hereinafter referred to as
"Party A") and I, Mr./Miss	(hereinafter referred to as "Party B") have
completely understood the rights and obligations of th	e scholarship recipient as well as the content of
the penalty clause for breach of the Agreement or u	nfulfilled articles. Both Party A and Party B
agree to sign this Agreement with the following articles for the parties to comply with together:	

Article 1: Eligibility of scholarship applicants

The students being graduated from the Master's Program and studying at the Ph.D. Program of the Department, or the Master's students of the Department having passed the application for direct admission to the Ph.D. Program.

Article 2: Scholarship disbursement guidelines

A scholarship of NT\$40,000 shall be disbursed every year, and the disbursement shall be made for two years. The number of scholarship recipients each year shall not exceed 5 students.

Article 3: Rights and obligations

Party B has to obtain a Ph.D. degree within the study period of the Ph.D. students as specified by Party A.

Article 4: Penalty clause for breach of the Agreement

If Party B fails to obtain a Ph.D. degree within the study period of the Ph.D. students as specified by Party A, or discontinues from the Ph.D. Program in the midway of the study period (including voluntary or non-voluntary discontinuance of schooling), then Party B has to return the full amount of the actually received scholarship to Party A. But if Party B's discontinuance of schooling is caused by a non-voluntary factor concerning personal health or family, and after the discontinuance of schooling is proposed and then reviewed and approved by Party A, the above restriction shall not apply to the student.

Article 5: Court of competent jurisdiction

In case of any disputes of the Agreement or any of them arisen from the Agreement, the parties should solve the disputes in good faith together. The parties also agree that if a lawsuit is required to be filed, the parties agree to take Kaohsiung District as the court of competent jurisdiction for the first instance.

Article 6: Effectiveness and amendments

The Agreement shall be effective from the signing date of the Agreement by the parties. What is left unmentioned in the Agreement shall be added or shall have the articles amended in writing after the parties have made consent.

Article 7: Number of copies of the Agreement

This Agreement is in duplicate, with Party A and Party B holding one original copy respectively.
